## TUITION

If accepted into Leadership Blair County, you will be billed for the tuition fee of \$1800, which covers all program costs and materials, including room and meals at the Retreat. Tuition is non-refundable and is payable in full by August 31<sup>st</sup>, unless other arrangements are made with Leadership Blair County.

To assure the diversity of the program, financial assistance, based on need and class composition, is extended once selection has been made to those persons or organizations who are unable to meet the tuition requirements. Since tuition grants are limited, each participant and sponsor will be asked to contribute some portion of the tuition. Payment plans are also available, in which tuition is paid over an extended period of time. A participant who is on scholarship is required to pay 10% of the total tuition costs prior to the orientation in order to demonstrate a personal commitment to the program.

## COMMITMENT

In order to accomplish Leadership Blair County's objectives, full commitment and participation of each individual selected is necessary. A participant is expected to attend all sessions, including:

**Orientation:** September (full day)

**Retreat:** October

**Program Sessions:** One full weekday per month from October through June  
(Dates are given for a full calendar year)

**Preparatory Work and Class Project:**

Special activities are arranged for class members to enhance their understanding of each program session. Each class member should make an effort to participate in as many of these special activities as possible. All are expected to complete the advance reading assignments prior to each session, in addition to participating in the class project.

**Commencement:** June

*Full support from the applicant's employer is required, both in terms of financial commitment and the time to participate effectively in Leadership Blair County.*

*Following completion of the program, participants are expected to stay active in the organization to continually enhance their Leadership experience and to help strengthen the program for the future.*

# LEADERSHIP BLAIR COUNTY TUITION GRANT APPLICATION

Tuition for LEADERSHIP BLAIR COUNTY is \$1800. It is expected that out of this total amount, each individual will contribute 10% toward the tuition, maximum of \$180, as their personal commitment to the program.

The policy of LEADERSHIP BLAIR COUNTY is to provide financial/scholarship assistance to those candidates who are accepted into the program and demonstrate need in order to fully participate. Financial assistance/scholarship is based on the number of requests received and the amount of funds available each year. Financial/scholarship assistance will not be granted for the personal \$180 portion under any circumstances. A payment plan for tuition may be established and the payment schedule will not exceed three months.

Consideration for financial/scholarship assistance is based primarily on demonstrated need (priority is given to those applicants who are employed in the non-profit sector or not employed).

Applicants employed by large, private-sector companies would typically not be eligible for assistance; however, to be considered for assistance, you and your employer must complete the following information and submit it to LEADERSHIP BLAIR COUNTY by June 30. It will not be part of the selection process; scholarship monies will be allocated once selection of the class is complete.
